

RESIDENT INPUT SUMMARY

9/15/16 to 10/17/16

Old Business

- 9/6 A Hilda Walker 20th Anniversary Celebration volunteer called requesting a hayride on October 13th. A message was left requesting more information on 9/6 and 9/14.
 - Contact was made, and on 10/13 a hayride was provided for the school's event.
 - 10/11 A thank you email was received from the committee contact person.

- 10/16 A Brookside Glen resident called to ask about the progress of a weedy area behind his home along Fairfield Drive.
 - 10/17 The resident was called, and provided with a log of the visits and work that had been done to this area. I also informed the resident that the area will be regularly monitored, and it will be included in future broadleaf applications and overseeding.

New Business

- 9/15 Preschool staff let maintenance know about an unusually high number of spider and insect sightings in the preschool rooms.
 - 9/16 (Friday after school hours) Insecticide spray was applied to the exterior foundation edge of the preschool wing.
 - 10/17 Pest control contractor, Bradley Pest Control, made their semi-annual visit to Park District buildings.

- 9/19 A Union Creek picnic shelter renter left a message at the front desk stating they had trouble locking up the restrooms at Union Creek Back shelter on September 18th.
 - 9/19 Locks were checked, lubed with WD-40, and the restrooms were cleaned and locked.

- 9/19 An email was received that a garbage can was missing from the Brookside Glen path.
 - 9/19 The garbage can was found in the tall native plants along the creek, and returned to its usual location.

- 9/19 A thank you email was received in regard to a homeowner association's bike bridge. The Park District had provided the association that this particular bridge was the responsibility of The Village of Frankfort, not the Frankfort Square Park District.

- 9/19 SSSRA staff asked park district staff to assist with their annual Oktoberfest event.
 - 10/1 A hayride was provided for the SSSRA event.
 - 10/4 A thank you email was received from SSSRA.

- 9/27 Enbridge Pipeline contacted park district maintenance staff regarding utility work they would be completing in the Lighthouse Point area that would require access to park district property.
 - 9/27 Staff thanked the utility for providing the information.
- 9/29 SSSRA staff emailed maintenance staff that their gutters were overflowing.
 - 9/30 Three downspouts were cleared of debris to re-establish flow of rainwater. Staff reported that a large amount of leaf litter was removed, but more work is required.
- 10/12 School District 161 staff returned an email in regard to the need to change times in the Mary Drew School parking lot light program.
- 10/14 A Community Park neighbor called to inquire about recent work at the tennis courts.
 - 10/14 A message was left, informing the resident about the park renovation OSLAD grant project, and to call back if additional information was needed.
- 10/14 Advanced Property Management called in regard to the maintenance of the park district pond.
 - 10/14 I called back and left a message asking the caller to identify the pond in question.
- 10/17 A Frankfort Square resident called and asked if the park district could repurpose sand from beneath her pool following its removal, stating it could be used for baseball fields.
 - 10/17 Staff returned the call and left a message requesting additional information, i.e. location and quantity of sand, but stated it was unlikely the park district would be interested in removing her sand.
- 10/17 An email was received that detailed a complaint about a Lake of the Glens Park neighbor burning on park district property.
 - 10/17 Following a site visit, a small campfire ring was found. The Tinley Park Fire Prevention Department was notified, and a letter was sent to the resident.
- 10/17 Village of Frankfort staff called to inform the Park Naturalist that they received a complaint that tall plants adjacent to the sidewalk along Pfeiffer Road are leaning over the sidewalk.
 - Natural Area staff will address the issue first thing tomorrow morning 10/18.
