

ORDINANCE NO. 22-12-346

ORDINANCE LEVYING AND ASSESSING THE TAXES OF THE FRANKFORT SQUARE PARK DISTRICT, IN THE COUNTIES OF WILL AND COOK, STATE OF ILLINOIS.

WHEREAS, the FRANKFORT SQUARE PARK DISTRICT, of Will and Cook Counties, Illinois is authorized by law in accordance with the Park District Code, and other laws supplemental thereto, to annually levy taxes on all of the taxable property in the District for various purposes of this Park District.

WHEREAS, the FRANKFORT SQUARE PARK DISTRICT, of Will and Cook Counties, Illinois established the estimate of levy during its Regular Meeting of the Park Board on October 20, 2022 in compliance with Section 18-60 of the Truth in Taxation Law.

WHEREAS, the FRANKFORT SQUARE PARK DISTRICT, of Will and Cook Counties, Illinois has complied with the Truth in Taxation Act (5 ILCS 200/18-60) by publishing notice of the December 5, 2022 public hearing in the November 25, 2022 edition of the *Daily Southtown*, a local community newspaper of general circulation of the District.

NOW, THEREFORE, BE IT ORDAINED by the Board of Park Commissioners of the FRANKFORT SQUARE PARK DISTRICT, in the Counties of Will and Cook, State of Illinois, as follows:

Section 1:

That exclusive of any and all taxes authorized by acts which by their terms provide that such taxes shall be in addition to taxes for general purposes, the sum of \$3,477,102 is hereby levied and assessed for the corporate purposes upon all property subject to taxation within the territorial limits of the FRANKFORT SQUARE PARK DISTRICT, as the same is assessed and equalized for the State and County taxes for the current year, in the following amounts and for the following objects and purposes.

Section 2:

The sum of \$526,500 is hereby levied and assessed for the general recreational purposes upon all property subject to taxation within the territorial limits of the FRANKFORT SQUARE PARK DISTRICT, as the same is assessed and equalized for the State and County taxes for the current year, in the following amounts and for the State and County taxes for the current year, in the following amounts and for the following objects and purposes: (70 ILCS 1205/5-2, 5-3a, and P.A. 97-974)

Section 3:

The sum of \$32,000 is hereby levied and assessed for the general audit purposes upon all property subject to taxation within the territorial limits of the FRANKFORT SQUARE PARK DISTRICT, as the same is assessed and equalized for the State and County taxes for the current year. (50 ILCS 310/9)

Section 4:

The sum of \$160,000 is hereby levied and assessed for costs of risk management expenses and purchasing insurance to protect against any loss or liability which may be incurred by the District. (745 ILCS 10/9-107)

Section 5:

The sum of \$266,000 is hereby levied and assessed for costs of the Special Recreation program. (70 ILCS 1205/5-8)

Section 6:

The sum of \$27,000 is hereby levied and assessed for costs of Paving and Lighting.(70 ILCS 1205/5-6)

Section 7:

The sum of \$136,000 is hereby levied and assessed for costs of Social Security taxes. (40 ILCS 5/21-110; 40 ILCS 4/21-110.1)

Section 8:

That summary of taxes to be levied and assessed upon all property subject to taxation within the territorial limits of the FRANKFORT SQUARE PARK DISTRICT, as the same is assessed and equalized for the State and County taxes for the current year is as follows:

Section 9:

Any funds on hand at the end of the fiscal year that are not pledged for or allocated to a particular purpose may, by action of the Board of Commissioners, be transferred to a capital improvement fund and accumulated therein, but the total amount of accumulated in the fund may not exceed 1.5% of the aggregate assessed valuation of all taxable property in the Park District.

Pursuant to Section 4-4 of the Park District Code (70 ILCS 1205/4-4) neither the Budget and Appropriation Ordinance of the District for the current fiscal year beginning May 1, 2022 and ending April 30, 2023 nor any other Budget and Appropriation Ordinance is intended or required to be in support of the tax levy made in this ordinance.

Section 10:

That the Secretary of the FRANKFORT SQUARE PARK DISTRICT is hereby directed to make certified copies of this Ordinance and to certify to the County Clerks of Will and Cook counties, State of Illinois, the amount required hereunder to be raised by taxation.

Section 11:

That the said tax so levied and assessed aforesaid be collected and enforced in the same manner and by the same officer as the State and County taxes.
